The Council has sanctioned the submission of the following Grace to the Regent House at a Congregation to be held on 24 July 2025, in addition to Graces 1 and 2 (*Reporter*, 6792, 2024–25, p. 734).

3. Regulation 1 of the Ordinance for Admission to Degrees (*Statutes and Ordinances*, p. 170) notwithstanding, OLIVIA JANE DOVERNOR of St John’s College be approved for admission to the degree of Doctor of Philosophy either in person or in absence, and an Order be issued to this effect.¹
